



Parent and Student Acceptance of Policy

1. Policies - I have read Odyssey Charter School's [Handbook for Students and Parents](#) found on Odyssey's website. I commit to supporting OCS in the pursuit of fulfilling its mission and its policies as contained in this handbook.

2. Positive Communication - I will promote the vision of OCS by using positive communication, courtesy, and respect when interacting with the staff, students, parents, and anyone else in the school community (including during carpool). I will follow the OCS communication model. Specifically, I will take any concerns I have directly to the person most able to successfully address those concerns and will work cooperatively to promote the school mission.

3. Volunteer Service - As a charter school, OCS is anxious to offer parents meaningful opportunities to serve the school community on a volunteer basis. I understand the school encourages every family to provide 40 hours (20 hours for single-parent families) of volunteer service each year.

4. Attendance - I understand federal law requires OCS to have 95% attendance. I will commit to minimizing my child's absences and tardies, submitting a "Scheduled Absence Notification" when applicable. I understand that if my child is absent 10 consecutive school days without prior written consent, he/she may be unenrolled from OCS according to state law.

5. Code of Conduct - I have read the [OCS Code of Conduct](#) and agree to reinforce with my student(s) its goals in the areas of dress, language and communication, and comportment.

6. Uniforms - I understand my child will be required to wear a school uniform. I have read the [OCS Uniform Policy](#) and will ensure my child is in daily compliance with the policy. I will ensure my child's uniforms are Odyssey approved, and I will contact the front office with any questions.

7. Library - I understand and agree to abide by the library guidelines regarding books and other materials loaned to me and my student(s).

8. Discrimination and Civil Rights - I have read, understand, and agree to comply with the policies described in the OCS [Disability Accommodations, Discrimination, and Civil Rights Notice](#).

9. E-mail – I understand the majority of school correspondence is done through e-mail. I will alert the school if I do not have access to email or if you are not receiving e-mails from the front office or teachers.

10. Acceptable Use Agreement – I have read Odyssey Charter School's Acceptable Use Agreement for [K-2nd Grade](#) and [3rd-6th Grade](#). I have discussed this agreement with my student(s), and they will comply with each item listed in the agreement.

11. Bullying – I have read Odyssey Charter School's [Bullying Policy](#). I have discussed this policy with my student(s), and we will all comply with each topic listed in the policy.

13. Vision Screening – I have read Odyssey Charter School's [Vision Screening Form](#) and give permission for my student to receive a vision screening during the school year. If I do not want my child to receive a vision screening, I will notify the front office at office@odysseycharter.net before my student's first day school at Odyssey.

14. School Surveys – I am opting in to school surveys. If I want to opt out, I will notify the front office at office@odysseycharter.net before my student's first day of school.

15. Toilet Trained – I understand Utah state law requires children to be toilet trained before kindergarten entry allowing exceptions for students with disabilities in IEP's or 504 plans.

16. Personal Device Policy – I have read Odyssey's [Personal Device Policy](#). I have discussed this policy with my student(s) and we will comply with the school policy.
